The selected candidate should not be working on temporary/permanent basis (Online/Offline) in any Government/Semi-Government Department in Jammu/Kashmir Division or anywhere else in the country and neither is in receipt of any scholarship or any other type of financial support leading to the award of any degree/diploma, etc. Furthermore, the candidate is not engaged on academic arrangement anywhere else.
 5. The candidates should join within a period of 05 days, failing which next candidate in order of merit shall be considered for hiring.
 6. In the event of any errors/mistakes in the calculation of merit/points based on the criteria, the hiring shall be subject to cancellation without any notice to the candidates.
