Subject: Inviting of objections for the Short-List/Waiting-List as per Revised Merit approved by the District Level Committee for Hiring of Cluster Resource Coordinators for Teaching Support-reg.

NOTIFICATION

Whereas, the Advertisement Notice for hiring of "**Cluster Resource Coordinators** for Teaching Support" till the end of the Academic Session 2024-25 (31-03-2025) for Government High & Higher Secondary Schools was issued vide Directorate of School Education Kashmir Notification No. 06 DSEK of 2024 Dated: 19-06-2024, issued vide endorsement No. DSEK/GS/573/E-7451889/775-89 Dated: 19-06-2024.

Whereas, district-wise and subject-wise General Merit Lists (Tentative) were published by the Directorate of School Education Kashmir and made available on the official website of the Directorate of School Education Kashmir, i.e., www.dsek.nic.in, for seeking objections/comments.

Whereas, it was also provided vide the aforementioned notification that the General Merit List published has been prepared as per the actual data provided in the Application Forms. The final selection of the candidates is subject to the verification of the information contained in their submitted applications/documents by the Committee to be constituted for the purpose. Candidates are reminded that it was mandatory to upload the corresponding documents for all degrees and qualifications mentioned in the notification and application forms, as well as any other required documents.

Whereas, pursuant to the directives issued by the Director School Education Kashmir vide Order No: 171-DSEK of 2024, Dated: 05/07/2024, issued vide endorsement No. DSEK/Estt-I/Gaz/824-86 Dated: 05-07-2024, this office, vide Order No.CEO/Sgr/CRC-2024-25/5871-77, dated: 08.07.2024 constituted a committee for scrutinization/verification of the documents submitted by the applicants for hiring of Cluster Resource Coordinators for Teaching Support.

Whereas, after the scrutinization of documents by the designated committee, some discrepancies were observed in respect of some candidates based on the actual documents uploaded and the information provided by the candidates, resulting in the framing of a revised merit list for each subject.

Now, therefore, this notification is published for the information of all stakeholders/candidates that the short-list/waiting-list as perrevised/redrawn merit, approved by the committee constituted for the purpose, is available on the official website, i.e., **ceosrinagar.com** and available in the office of the undersigned for inviting objections, if any. The same shall be submitted in the office of the undersigned within a period of **(03)** days from the date of issuance of this notification with cogent documentary proof, failing which no claim whatsoever shall be entertained after the expiry of the given stipulated time.
