 - d) **Date of Birth Certificate**
 - e) **M.Phil./Ph. D Degree Certificate, if applicable**
 - f) **Publications; if any.**
4. The hired candidate shall neither be working in any government/ Semi-government department on temporary/permanent basis nor enrolled in any educational institute (Online /Offline) for pursuing any higher academic/ professional course/ degree.
